The extended essay (EE) is a mandatory core component of the IB Programme. It is a 4,000 word research paper that allows students to conduct in-depth independent research or investiga-

Senior Molly Crabb discussed her paper on Epigenetics, gene suppression of methylation by environmental factors rather than mutation. She was even surprised by her initial research when she found that plants and some animals can be profoundly affected by the treatment of their ancestors. When asked what she found most rewarding about the EE process, Molly said, "It was rewarding to actually have an opportunity to learn something I was really interested in and have an ambitious paper and experiment.

Obama and the curious case of immigration reform

Known as the melting pot, the United States has always maintained an influx of immigrants. The country's foundation was built by immigrants. However, in recent years the prevalence of undocumented immigrants, approximately 11 million of them, has led to complications. The naturalization process, bogged down in bureaucracy, is overwhelmed. Large corporations take advantage of undocumented workers by underpaying and overworking them without regulation. In efforts to combat this, President Obama gave a speech that invoked his executive powers as President in late November. This was to the extreme chagrin of Congress, particularly now that

In a speech released on November 20, President Obama unveiled executive actions taken to reform immigration. This controversial action, if not disputed, could affect four million immigrants living in the US.

the partisan balance has shifted following mid-term elections. In his speech, President Obama granted temporary legal reprieve undocumented immigrants

Arrivals in order to allow young immigrants under 30, who are here legally, to apply for a deportation referral. Both groups will have to reapply every three

years to maintain their status. The benefit of this is that immigrants would not have to fear deportation within the three year reprieve period for receiving say, a traffic ticket, because they are not breaking the law by being in the country. The act also increases funding for border control and modify the current processes of immigrant detention. Special considerations will be given to immigrants whose work would improve the US; engineers, scientists, mathematicians. All in all, the measures enacted by the action will impact around four million immigrants, according to the Migration Policy Institute. These policies will not grant immigrants access to the Affordable Care Act or expand visas for migrant farm workers. Controversies regarding the legality of this action have abound-

Becoming an expert by yourself is an extremely rewarding feeling." The EE Extravaganza allows seniors to reflect on what they have learned, and Molly learned firsthand that science requires more failures than successes and sometimes is not definite. Molly added, "Even though my hypothesis was not correct, I still learned more and am in the process of finding success!" Senior Hailey Glick believes that the value of the extended essay lies in its ability to be applied in a variety of situations. Her essay analyzes the United States' lack of involvement in the Holocaust, a topic she chose because she is Jewish. She also elected to undertake this subject to improve in her weakest subject, history. Hailey has used her essay as a topic in scholar-ship applications, college interviews, and even a few Jeopardy questions. When discussing the most rewarding part of her experience, Hailey said, "The best part was the connections I made with research professionals who focus on my topic!"

A lot of the extended essays also included experiments, such as senior Tristan Emm's physics investigation. He conducted an experiment incorporating the Rubens tube, a tube that demonstrates standing sound waves using flames. Tristan found that his knowledge of physics expanded beyond the experiment, however. "In the process of the paper portion, I learned new physics concepts about standing waves and nodes and anti-nodes," Tristan said, "I found it very surprising that so few scientific research papers were published about it." The extended essay allows students to expand their knowledge and investigate new topics that they normally would not in the classroom.

The Extended Essay Extravaganza provided the IB class of 2015 with the opportunity to present their research in front of parents, teachers, and peers. It was also a valuable learning experience as many discovered that it is easier to write about your research than talk about it. Many IB juniors were also in attendance and were able to understand the work that goes into this paper and receive advice from the seniors on the process.

ed. Critics say that the President acted outside of his powers in issuing a blanket reprieve. Since what Obama is offering is temporary reprieve rather than complete amnesty, which has been done by presidents in the past including George W. Bush, it seems to be allowed thus far. The legality of executive action relies on the concept of prosecutorial discretion. This rule allows the head of the executive branch to decide where to concentrate law enforcement so that one section, such as immigration, can receive more resources. Even so, the distinction between what is allowed, and what is not, is murky. Sophomore Kelly Hruska said, "I can understand and support a president taking matters into their own hands, but it would make me slightly antsy to see checks and balances being disregarded."

Whether or not President Obama's actions are entirely justified, his initiative has succeeded in creating a dialogue regarding immigration. His efforts are focused on the areas of making naturalization more efficient, strengthening border control, cracking down on companies who exploit undocumented workers, and creating paths to citizenship in order to encourage immigrants to come out of the shadows and get right with the law without fear of immediate deportation. Junior Jessica Lane said, "I think it was a really admirable decision to make, and I'm so glad that steps are finally being taken to make sure there's less of a risk for immigrants of being exploited for the benefit of businesses and corporations."

Not funny anymore Allegations against Bill Cosby

Actor Bill Cosby has been facing much criticism recently over allegations that he repeatedly raped and drugged young women earlier in his career. Although these allegations have been around since 2005, public attention was brought to them by a recent viral video of comedian Hannibal Buress. The video shows Buress doing a bit about the lack of public awareness of the allegations. Once the video gained popularity, news outlets began to cover the situation as new women came forward.

So far there have been over 20 women that have publicly accused Bill Cosby of sexually assaulting them. Many of them tell similar stories of being drugged by him and losing consciousness. One of the women to come forward recently was Joan Tarshish. On November 17, she spoke out, saying that Cosby sexually assaulted her on two separate occasions. She claimed that in 1969, when she was 19, Cosby made her a drink in order to drug her and make her pass out. Tarshish explained that she did not go to the authorities because she was afraid that no one would believe her. The day after Joan Tarshish came forward, model Janice Dickinson described a similar incident that occurred in 1982. Dickinson recollects that Cosby gave her a pill and a glass of red wine. This caused her to pass out so that Cosby could sexually assault her.

Many of the women cite fear of humiliation and disbelief as their reasons for not sation, while fourteen other victims of sexual assault were also willing to testify in the case. The case was settled outside of court.

The huge wave of allegations against Bill Cosby is distressing for many people because of Cosby's influence as a role model and household name. Senior Matthew McCloskey said, "It's strange to think that someone who was a role model for so many people might have done these aw-



Alarming infant mortality rates in US

infants born will not make

Imagine remaining nameless until vour teeth grew in or until your first birthday. In some cultures, that is a familiar practice because of the extensive amounts of infant deaths. The amount of infants that die before the age of one per 1,000 births, also known as the infant mortality rate, is used to measure the health of a nation. A high infant mortality rate is often contributed to living in a third world or developing country. In these countries, every day resources such as clean water, adequate food sources, and housing can be scarce, limited, or nonexistent. Along with little to no resources, the women are generally inadequately educated.

It is very true that developing countries tend to lack in many areas, such as in their poor standards of living, limited resources and little to no education, let alone basic cleanly practices such as sterilizing utensils and hand washing. As a result, many of the

it to their first birthdays. In the US, a majority of Americans receive some form of education, adequate resources to survive, and safer living conditions than those in developing countries; however, an alarming infant mortality rate of approximately six infant deaths per 1,000 births exists. Senior Ashlie Johnson said, "It is a embarrassment national because the infant mortality rate in the US is higher than any of the other 25 wealthy countries' mortality rates." According to the U.S. Department of Health and Human services, the United States spends more on health care than any other country but still lags behind most industrialized nations.

In South Dakota, there are five counties in which less than fifty percent of pregnant women receive prenatal care during their first trimester. They also ranked fifth highest in the nation for mothers that smoke during their pregnancies. Consequently, South Dakota's infant mortality rate approximately eight infant deaths per 1,000 births. Senior Chyen Charles said, "Due to some people's choices, they affect the health of their infants during development in the womb, which causes later health defects after birth that can lead to death of the infant." The American Indian population higher tobacco use than the national average. As a result, the infant mortality rate amongst American Indians is about twelve infant deaths per 1,000 births.

Before advances in medicine and technology, infant mortality rates could range from 200 deaths per 1,000 births and up. Prior to the nineteenth century, basic preventive practices were not widely utilized until Ignaz Semmelweis made the suggestion of doctors washing their hands before delivering babies, after drawing a coorelation between infants dying and lack of routine hand washing.

High infant mortality rates are often associated with areas around the world that we tend to generally see as less industrialized or even lacking in what we know as second nature practices such as hand washing, proper diet, etc. However, being an industrialized country, we too have an alarming number of infant deaths prior to the age of one. High infant mortality is no surprise to this country varying reasons, whether it be by choice, limited income, person belief, or coincidence.

Croatia is a small county on the edge of Southeast Europe, bordering countries like Hungary to the north and Serbia to the east. Throughout history. many different groups have influenced Croatian

ous points in history have helped to shape Croatian culture. The food of Croatia clearly reflects the exciting history of the country. Mediterranean staples like filo dough, figs, and olive oil find their way into some Croatian dishes. Tomatoes and pasta show the Italian influence on parts of Croatia. Croatian dishes are diverse and draw from a large array of ingredients. Senior Bella Cermin explains, "Croatians like goulash, which is a stew with beef; gnocchi, which is a noodle made of potato; and ajvar, which is a spread we many Croatians dishes. There are also plenty of delicious desserts in Croatian cuisine. According to Bella, "We have something called krafne, which is similar to donuts. We typically fill those with marmalade and nutella."

Ingredients

- Dough
 - 3 ½ cups flour 1 tsp baking powder
 - 1 egg
 - ½ cup sugar
 - ²/₃ cups butter
 - ½ tsp cinnamon (optional)
 - 2 Tbsp breadcrumbs
 - Powdered sugar for top ping

Filling

- About 10 apples
- 3 Tbsp sugar
- 1 tsp cinnamon

Directions

- 1. In a large bowl, mix together the egg, sugar, and butter.
- In a separate bowl, combine the flour, baking powder, and cinnamon.
- Pour the flour into the wet ingredients. Mix into a dough, taking care not to overwork the dough. Wrap and let cool in the refrigerator for about 30
- Peel apples and grate into a large bowl.
- Mix in the sugar and cinnamon.
- Preheat the oven to 350 degrees.
- Divide the dough into two equal parts. Roll out both halves on a floured surface.
- Line a 9x13" baking pan with one half of the dough, covering the bottom and sides of the pan.
- Sprinkle the breadcrumbs over the dough, then add in the apple filling.
- 10. Use the rest of the dough to cover the pan.
- 11. Bake for 45 minutes, then sprinkle with powdered sugar.
- 12. Cut into squares and serve.



Obama children face criticism

Obama's President daughters, Sasha and Malia, appear to be two of the luckiest teenagers in the United States. Over the years, they have enjoyed performances by the Jonas Brothers and Beyoncé, have had the unique opportunity to meet the Pope and the Queen of England, and have traveled across the world. Relatively speaking, they have been largely exempt from the constant attention of the media. Like presidential parents of the past, President and firstlady Obama have taken careful measures to protect their daughters and ensure they lead as normal of lives as possible. However, as Sasha, 13, and Malia, 16, continue to grow up in front of the nation, how much longer will this sense of privacy and independence last?

This past November, the two girls attended the presidential turkey pardon, a Thanksgiving tradition held every year at the White House since the Truman administration. Lauten concluded her on-line post by encouraging Sasha and Malia to dress like they "deserve respect, not a spot at a bar." Lauten's post was met with fierce backfire on social media. Shortly after, hundreds of people demanded she be reproved for her actions, expressing their anger through the Twitter hashtag #FireElizabethLauten. Lauten later resigned from her position under

Republican Steven Fincher.







On August 8 the Ebola, or Zaire, virus outbreak was officially deemed a 'public health emergency of international concern.' Ebola was discovered in the 1970's, and while we do not know the exact origin, it is believed that fruit bats are the natural hosts. Cases first began to pop up in December of 2013 in New Guinea. The disease quickly spread, and by the summer of 2014 had reached other West African countries, including Liberia, Sierra Leone, Nigeria, and Senegal. The epidemic has severely strained the region's healthcare capactities. Overall, there have been about 7000 confirmed deaths due to Ebola. The US was given a scare when Thomas Duncan became the first person in the United States to have the disease. Since his death on October 8, there have been three additional cases in the US. The CDC has been working closely with airlines and ports to assess the health of passengers coming into the US from hard-hit areas. The average fatality rate for Ebola is around 50%. There is no proven vaccine for Ebola as of yet; however, scientists predict that one will be ready by summer 2015.

On October 10, the state of North Carolina recognized the right of same-sex couples to marry. The change stemmed from a ruling given by the Fourth Circuit Court of Appeals, in which they found that Virginia's ban on same-sex marriage was unconstitutional. Because North Carolina is also in the Fourth Circuit, the ruling applied to North Carolina's Amendment One. However, there was no change in North Carolina until District Court Judge Max O. Cogburn, Jr, applied the decision to a court case in the state. Although most counties were not able to begin distributing the modified marriage licenses on October 10, Wake County was able to begin giving marriage licenses that afternoon.

North Carolina is not the only state that has recently changed its laws on same-sex marriage. There are currently 35 states that recognize the right to marriage for all couples, accounting for a majority of American citizens. This is mostly due to action taken in the judicial branch to overturn laws on the state level. In many states that still do not recognize same-sex marriages, rulings have been made in favor of same-sex marriage but are awaiting further progress.






"Black lives matter" protests begin throughout the country







StayFocused is a similar application for Google Chrome where you input a list of blocked and allowed sites. This program allows you to change the settings and the lists at any time unless you are in nuclear mode, which is similar to SelfControl. This sounds extreme but is very helpful.

FORCEdraft is a similar program geared towards writing. Instead of controlling access to social media, it controls the amount of time, or number of words you write. The full screen program cannot be minimized until either the time or word count requirement is met. A similar online program is Zen Pen. The website is very simple looking with an area for text and one simple sidebar. This toolbar includes a full screen mode, a target word count, and a save feature. If you input your target word count, a thin line will appear to the right of the scroll bar. This line will grow as you get closer to reaching your word count goal. Not only are these distraction free zones, but they also encourage students to reach their required word count.

not involve any revolutionary technology; they instead require good old fashioned self-control. Junior Emiliano Maltrana admits that his biggest distraction is his phone: "Getting notifications and messages while I'm doing homework disrupts my thought process and I lose focus." His solution is simple: "I leave my phone in my room and try to do my homework somewhere else so I don't have the option of getting distracted by it." Blocking out distractions is one part of a good time management strategy. The other is prioritizing. Senior Danielle Wilder, who has two jobs in addition to her school workload, does "homework both in the morning and at night. I prioritize based on what is due tomorrow and with my extra time I work ahead or catch up on sleep." Making a balanced plan and sticking with it can result in much better grades and a much less stressful journey there.



Music Now The classical years

Relaxing, suspenseful, and upbeat are three very different adjectives, but they all do have one thing in common: they all can be used to describe classical music. There is no definite term to describe classical music. Some people have said that classical music is any form of music that has been around for centuries, while other people claim that classical music is music created using violins, pianos, and other instruments. Despite its definition, many people think that classical music has died out completely. However, classical music has existed for many years and continues to survive today.

Classical music originated from ancient Egyptian music, more specifically the Egyptian orchestra, which was created in 2695 B.C.E. After the fall of Rome, classical music was divided into different time periods. The first was the early period, and the first division of this period was Medieval music (Fall of Rome or late 400 C.E. - 1400). Chant was the predominant form of music during this time and fell under two categories: Gregorian chant or songs sung one note at a time, and polyphonic chant, which came after Gregorian in the Middle Ages and consists of two or more independent lines sung at the same time.

The next division, known as Renaissance music (1400 - 1600), increased the use of instruments and began using bass instruments. One of the bass instruments they used was the bassoon, a woodwind instrument designed to play low tones. They also began playing the harp, the flute, the trumpet and early keyboard instruments at this time. Sheet music had begun to form as well, so that musicians could play without the need of a composer.

After Renaissance music, a new music period emerged: Common Practice period. This is when the main structure for current classical music finally formed and when the most famous composers were alive. The first division of this period, Baroque music (1600-1760) caused classical music to become much more complex by using a continuous bass line and instruments such as the violin and the organ. Famous German composer Johann Sebastian Black also lived during this time but did not become famous until centuries after his death.

Classical period music (1730 - 1820) overlapped Baroque music, but still made a few changes to the genre at the time. In this time, the piano became the dominant keyboard

instrument in an orchestra, and clarinets were being used more often. Joseph Haydn, now known as "Father of the Symphony" and Wolfgang Amadeus Mozart created classic pieces of music and, in turn, caused the popularity of classical music to increase greatly.

Overlapping the end of the Classical period music was Romantic music (1780 - 1910),where emotions began to intertwine with how classical music written. This era was best known, however, for one of the most famous composers in the world, Ludwig van Beethoven. Despite being deaf, Beethoven wrote some very famous pieces, such as Für Elise and Symphony No. 5. It was also during this time period that pianos became popular, and more percussion and brass based instruments were being used.

The next time period, known as the Modern and Contemporary era, which started in the late 19th century and continues on today, saw a large dip in classical music's popularity. Diversity was encouraged in classical music, but as it became more diverse, entire new music genres were formed. There are still many examples of classical music today, such as in cartoons and Millbrook's orchestra. Though the future of this genre remains unknown, it is still known as the basis for every music genre we know.

America does not have the best track record when it comes to racial issues. Here in the 21st century, we like to think that systematic racism has been expunged from public policy, but that could not be further from the truth, particularly in the case of drug policy. The War on Drugs was created in 1982 by the Reagan administration to garner support for its second term, despite the fact that drug abuse was on the decline. A 'tough on crime, tough on drugs' rhetoric was popular at the time. Anit-drug propaganda featured dominantly black Americans as drug users, forever casting them into a role that deomonized them and guranteed that they would always be regarded with suspicion by law enforcement. However, the effects of this policy can still be observed today, and they are not positive.



This means that a person found with three grams of crack cocaine could get a four year sentence for instance, but someone found with powder cocaine could only receive that same sentence if they had three hundred grams of the substance. Almost eighty percent of sentenced crack cocaine offenders were black in data found by the US Sentencing Commission in 2009. In 2010, the Drug Policy Alliance's lobbies to reduce the sentencing ratio to 18:1 were successful.

Even though we have disparities are just one example of how much further we have to go. To reduce the amount of nonviolent minority prisoners, and the subsequent effects their imprisonment places on their families and communities, we must take racial bias out of drug policy and enforcement.

A dangerous love Teen dating violence

Love, defined as an intense feeling of deep attraction, is an emotion many teenagers have felt in the past or currently feel for someone else. Yet, when it comes to being romantically involved with someone, 1.5 million high school students have been intentionally physically harmed in the last year, by the person they were 'in love' with. Sadly, most of those students also stay with the abuser, making excuses for the abusers behavior.

Violent behavior becomes apparent between the ages of 12 and 18, and dating begins around seventh and eighth grade, increasing the likelihood of dating violence. The biggest problem involving teen dating violence is that only 33% of teens are likely to tell anyone about the abuse, due to both lack of knowledge regarding the law and an understandable want for confidentiality that has been fed by their fear. Also, most states do not include dating in their definition of domestic abuse, so the abused are unable to receive restraining orders against

abusers. their Dating violence in teens is an ignored problem, that once faced could make a huge change within teenagers' many lives. Even parents are not knowledgeable about the violence

that could be currently occurring within their teenagers relationship, and even worse, 81% of parents believe that teen dating violence is not an issue or are unsure if it is an issue. That lack of knowledge is something that we need to put an end to, instead choosing to educate both parents and teenagers on the dangers and reality of teen dating violence.

Teen dating violence also has many longlasting effects on the abused. Victims

relationships, especially those only in their adolescence, have higher risks of developing substance abuse problems and eating disorders. They are also at a higher risk of promiscuous behavior and further domestic violence.



Additionally, physical and/ or sexual abuse victims are six times more likely to become pregnant, and two times more likely to get an STI. Furthermore, one out of two victims of violent relationships commit suicide, compared to 12.5% of non-abused boys and girls.

When it comes to North Carolina law regarding teen dating violence, our state allows us to get a protection order. If you are under the age of 18, then you need the person who has

custody of you to file for a protection order. You also need to prove to the court that giving you a protection order is necessary. How do you know if you are a victim of teen dating

violence, or part of an unhealthy relationship?

Some of the warning main signs to look out for from your partner extreme are jealousy. an e x p l o s i v e temper, constant put-downs himself. of erratic an mood,

extreme possessiveness towards you, fake accusations, physically inflicting pain on you, and repetitive pressure on vou to take part in sexual acts. If you find that your partner or relationship fits these qualities, try to find a trustworthy adult to talk to. Also you can check out the website www.loveisrespect.org to learn more about teen dating violence, and get a chance to speak with a knowledgeable adult on how to handle what you are going through.

College football playoffs

The national championship trophy is not all that changed in the college postseason football this year. January 12 marked the first day a national champion was determined by the new College Football Playoff Selection Committee. Four semifinalists were chosen from the ten Football Bowl Subdivision (FBS) Alabama conferences. was ranked number one followed by Oregon at number two, Florida State at three, and Ohio State at four. Big 12 Contenders Texas Christian and Baylor were left out of the top four after Ohio State's dominating win over Wisconsin in the 10 championship game. The Big 12 teams were left out because the conference does not have a championship game, and TCU and Baylor were co-champions of the conference. Ohio State, the four seed, went on to beat number two Oregon and Hesiman winner Marcus Mariota to become the first ever FBS playoff national champions.

The new playoff system was put in place to keep the excitement from the regular season continuing throughout the postseason. The College Football Playoff makes it so that every game counts even more than they have in the past. The new format includes a four-team playoff system. The four teams that participate in the playoff bowl games are determined by the selection committee that consists of a group of former coaches, student athletes, administrators, journalists, and current athletic directors. The selection committee meets throughout the college football season to determine rankings of teams in the FBS conferences. At the end of the regular season, the four highest ranked teams play each other in two semi-final bowl games that change every year on New Year's Day. The semi-final games are rotated through the New Year's Six bowl games: the Sugar Bowl, Rose Bowl, Orange Bowl,

Cotton Bowl, Peach Bowl. and Fiesta Bowl. The two winners of these games will go on to compete for the title.

For the first playoff, number one Alabama played number four Ohio State in the Sugar Bowl, while numbers two and three, Oregon and Florida State played in the Rose Bowl. These four schools were selected by the committee because of their strength of schedule, head-to-head matchups, championship games, and other factors.

In the Sugar Bowl, fourth ranked Ohio State upset number one Alabama 42-35. After the Rose Bowl, Oregon also advanced to the championship game after their dominating 59-20 win over last year's champions national Florida State. The game featured matchup between last year's Heisman winner Jameis Winston and this year's winner Marcus Mariota. It was just the third meeting of two Heisman winners in college football history.

Although many support

the new playoff system and believe it has been a good change for college football, there is some talk that there should be more than four teams in the playoff. Senior Jenna Franciosi "The agrees: selection process in ranking and choosing football teams is an art. Football is popular in some measure because the outcome of a game between evenly matched teams is so often decided by emotional commitment, momentum, injuries, officiating, and sheer luck. There's no way they could've picked just four teams perfectly. more teams needed to be included in order to correctly show who is 'number one."

The new college playoff changed college football significantly this year. It is likely that without this change, Oregon and Ohio State would not have been in the championship game because they would not have been ranked one and two through the old system. The new College Football Playoff system will be in place for the next 12 years. Senior Cole Tolson said, "I feel the playoffs made college football much competitive than in the past years with the BCS bowl system. The games were very exciting."

The risks and precautions of snowboarding

On Christmas Day, 1965, Sherman Poppen combined two skis together to make first snowboard, initially called a snurfer, for his daughters to surf down a small snow slope. Since then, the sport has gained popularity, and snowboarders have begun to take on more dangerous areas and slopes. Amazing tricks and high risks have caused many to want to join in on this sport, but some realize just how dangerous snowboarding is. "I have never considered snowboarding because a lot of my friends have been injured in the sport," said junior Siddharth Jindal. There are many risks that a snowboarder must be aware of before they begin.

It is also necessary that they learn how to prevent these dangers from occurring.

There are a multitude of injuries that can happen during a collision or fall while snowboarding. The most common injuries are to the wrists. As a person is falling, his or her first reflex is to land on the palms of his or her hands. It protects the rest of the body, but it causes all the pressure of the fall to go towards the wrists. One common prevention for this is to land on the elbows, but this can cause serious damage to the elbows as well. The best method for one to land is with his or her entire body, dealing minimal damage across all of it. Due to the feet being strapped in, the amount of leg injuries is minimal, but still possible, so try to avoid making too sharp turns that can twist your legs. Proper safety equipment should also be used, such as knee pads, gloves, and soft boots, as hard boots can damage a person's feet during a

crash. Failure to use this equipment often results in

higher risk of injury. Beginners are more likely to get injuries due to lack of experience. In fact, about half of a injuries snowboarder's occur during their first season of snowboarding. One of the biggest struggles beginners have is keeping control of their board. "The worst experience I've had snowboarding occurred the second day of learning. I was practicing to control the board; I lost control on a medium slope and could not stop unless I crashed, so I took the fall and ended with minor injuries," said junior Kerem Korkmaz. Falls are the leading cause of injuries in snowboarding and are typically caused by lack of control of the board. There are several ways to maintain control of a board, but the most common way snowboarders stay in control is by moving in a zigzag pattern. This causes the snowboard to slow down and makes it easier to control.

Jumps are, unsurprisingly, the second most common cause of injury snowboarding. Making a jump at high speed can be very difficult to pull off, and landing is even more difficult than jumping. One way to avoid getting into a crash is to watch how others take on the jump, observing their speed and motion. Then, when performing the jump, a snowboarder must feel that they are in control. If they feel like they are not in control of the board, they should try to avoid the jump entirely. When approaching the feature, bending the knees slightly, then straightening them as the feature is reached is essential for completing a safe jump. When landing, try to make sure the board is level with the ground and land evenly with both feet.

Snowboarding can be a dangerous sport, but with these precautions in mind, it can be much more fun and less hazardous than one may think.




